Grant Purpose

Rural Workforce Agency Victoria (RWAV) is a non-profit government funded organisation improving healthcare for rural, regional and Aboriginal and Torres Strait Islander communities in Victoria.

The RWAV Rural Ambassador Student Grant aims to enhance opportunities for students interested in rural health to participate in, or lead, events and activities that promote rural health.

The grant aims to raise awareness of the opportunities available in rural healthcare to young people. This is a crucial step in attracting and retaining a future rural health workforce.

Applicants can apply for funding to:

- Attend rural health events such as conferences, speaking events, rural career events, community activities or cultural awareness/safety training.
- Organise or host their own rural health initiatives.

RWAV may also use the funding to support rural health ambassadors to act as RWAV representatives at events promoting rural health careers such as conferences, mentoring dinners, community activities and youth activities.

*Applying for this grant does not guarantee that funds will be awarded.

Funding

Applicants can apply for funding for up to \$2,000 once per year. At the discretion of RWAV, funding items can include:

- Travel costs
- Resource development
- Event tickets
- · Registration fees
- Venue hire
- · Equipment hire/purchase
- Talent fee
- · Accommodation and meals

*Applicants are encouraged to apply for funding to cover all funding items from the above list that will be applicable to their event/activity. Please note that this does not guarantee that all funding requests made on the application will be filled.

The expenses and the amount awarded to each applicant will be at the discretion of the RWAV Future Workforce Program Officer and details indicating where the funding can be spent will be specified in the agreement letter.

Grant funding cannot be used for the following activities:

- Recruitment and relocation grants to health professionals to cover expenses that are covered by their employers
- Recruitment and relocation grants to cover expenses associated with international relocation, including visa costs and international flights
- Purchase of land
- · Major capital expenditure
- · Retrospective costs
- Costs incurred in the preparation of a grant application or related documentation
- Major construction/capital works
- Activities which support political campaigns
- · Grant recipient staff overseas travel, and
- Activities for which other Commonwealth, State, Territory or Local Government bodies have primary responsibility.

Eligibility

We are seeking applicants who are representative of rural health career pathways, are passionate about rural health and want to enhance their knowledge of rural health. Applicants should seek to further develop their rural health career prospects or inspire and support the future generation of rural health practitioners. Applicant can be a student body of any health discipline or organisation promoting health and careers in health.

Requirements:

- Applicants must be studying a health discipline at a Victorian University or Tertiary Education provider or; must be an allied health, nursing or medicine graduate including those enrolled in internship and registrar programs
- Applicants must show genuine passion and dedication to rural health
- · Activity must be undertaken in Victoria
- Applications must be submitted and approved prior to the activity/event taking place

*If successful in obtaining a grant the applicant must submit a brief activity report including photos or video. Images and text may be published by RWAV to promote Future Workforce initiatives and RWAV may call on you in the future to assist with promotional activities. Applicants will be required to provide permission for images and text to be used. The activity report must be submitted within four weeks of completing the activity to FutureWorkforce@rwav.com.au

Assessment & Outcome

Applications will be assessed by the RWAV Future Workforce Program Officer.

- Applications for RWAV Rural Ambassador Student Grant 2021 are considered throughout the financial year, funding will cease when expended.
- All applicants will be notified via email of the outcome of their application within two weeks of receipt of receiving a completed application.

Grant Payment

As part of the application process applicants must provide quotes to RWAV to support their request for funding. After the activity has taken place paid invoices must be supplied to RWAV and any funds that were not utilised must be returned to RWAV. This arrangement will be stipulated in an agreement letter that all applicants must sign prior to receiving any funding.

Grant funding will be paid via electronic funds transfer upon receipt of the signed agreement letter. Funds can take up to ten (10) business days to process.
